# THE TRUTH WILL SET YOU FREE ...

Across the world — spoken in hundreds on languages — this simple statement has touched countless people. But there is at least one place where TRUTH is not honored .....TEXAS.

For 14 years Tony Medina has been telling people he was not guilty of the Capital Murder charges that sent him to death row at the age of 21.

The nightmare began for Tony on January 5, 1996 when he was arrested by the Houston Police Department. Asked about the crime—he told the truth—that he had nothing to do with it and was not in the car when 2 innocent people’s lives were taken in a drive-by shooting. Throughout his trial, that started on July 24, 1996 and ended on August 1, 1996 with Tony being sentenced to die by lethal injection, he continued to tell the truth - that he was innocent of the charges. From the day he was delivered to death row on September 13, 1996 Tony has struggled to have this same truth heard.

In the summer of 2001 Tony got part of his wish answered. A team of lawyers who believed in him found evidence that proved Tony was infact telling the truth all along. After hundreds and hundreds of hours of: re-investigating the facts of the case, pouring through thousands of pages of files, speaking to new witnesses and getting their statements, the truth was proven.

The Houston Police Department and the Harris Country District Attorney’s Office knew another man was guilty of this crime but suppressed evidence, used perjured testimony and the help of a completely ineffective defense team to send Tony Medina to death row for a crime HE DID NOT COMMIT.

## **FACTS THAT WERE DISCOVERED BY TONY’S ATTORNEYS.**

- 5 Days after Tony was arrested the Houston Police Department issued a memo warning its officers that Dominic Holmes was „to be considered armed and dangerous“ and was „suspected of being the shooter“ in this crime.

- Dominic Holmes and a close friend were both charged with this capital murder days before Tony, only to have their charges dropped after pointing the finger at Tony.
- Dominic Holmes talked for months to others about a plan to seek revenge against a rival gang for his friends death.
- Dominic Holmes threatened other gang members to get them to help blame Tony Medina for this crime.
- The District Attorney’s Office withheld the criminal histories of at least 4 of it’s critical witnesses whose lengthy criminal records would have made them seem less credible to the jury.
